

LITTLE SWITZERLAND COMPETITION RELEASE OF LIABILITY

PLEASE READ CAREFULLY BEFORE SIGNING. THIS IS A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS.

Of my own free will, I agree to enter and compete in a competition at Little Switzerland under the terms contained herein on behalf of myself and/or my minor child/ward.

I understand that skiing in its various forms, including downhill skiing and snowboarding, and this competition involve risks, dangers and hazards that may cause serious personal injury or death and that injuries are a common and ordinary occurrence in this sport and this competition. Risks include, but are not limited to, changes in terrain, weather and snow surfaces, ice, moguls, bare spots, debris, fences, posts, trees, lift equipment and towers, rope tows, light poles, signs, buildings, roads and walkways, ramps, half-pipes, jumps and other terrain features, padded and non-padded barriers, grooming equipment, snowmobiles, collisions with other persons and other natural and man-made hazards. I freely accept and assume the risks associated with skiing in its various forms and this competition.

I represent that I possess the necessary skills and physical ability to compete in this competition in such a manner that I will not endanger myself, other competitors, spectators or other persons. I understand that as a skier/snowboarder, I am bound by certain Wisconsin state laws including the Wisconsin Alpine Sports Act and the Skier Responsibility Code (known as "Your Responsibility Code"). I understand that it is my responsibility to inspect the course and terrain prior to attempting to compete to avoid falls and collisions and to avoid injury to myself and others. I understand that I am responsible for inspection and maintenance of my equipment, including skis, snowboards, bindings, boots, poles and restraint devices or leashes. I agree to use restraint devices and/or leashes at all times. **I understand that inverted aerial maneuvers are not recommended.**

In consideration of the permission to compete in this competition at Little Switzerland and use its facilities, **I RELEASE FOR MYSELF AND/OR MY MINOR CHILD/WARD AND FULLY DISCHARGE Schmitz Brothers, LLC, its owners, officers, shareholders, agents and employees from any liability resulting from any personal injury to myself, including death, or damage to my property which is caused by the BREACH OF ANY EXPRESS OR IMPLIED WARRANTY or the NEGLIGENCE ACT OR OMISSION of Schmitz Brothers, LLC, its owners, officers, shareholders, agents or employees, including any NEGLIGENCE ACT OR OMISSION in:**

- the preparation, organization, coordination, operation and supervision of the competition;
 - the preparation, design, location, construction, installation, setting, classification, labeling, maintenance, operation, inspection, maintenance, repair and supervision of the competition course(s);
 - the instructions given or not given to me concerning the competition, the competition course(s) or any part thereof;
 - grooming, snow-making, snowmobile operations, the operation of chair-lifts and rope tows, and chair-lift and rope tow loading and unloading operations for the competition;
 - padding or non-padding of natural and man-made obstacles and hazards; or
 - posting or failure to post warnings, signs, fences or other cautions or barriers.
- I accept full responsibility for any injuries or damages to me or my minor child/ward which may result from the participation in this competition, and it is my intent to **HOLD HARMLESS** Schmitz Brothers, LLC, its owners, officers, shareholders, agents or employees for any injury sustained by me, including death, while participating in this competition. I agree not to bring any action or suit against Schmitz Brothers, LLC, its owners, officers, shareholders, agents or employees for any injury or damage.

I understand that, for a fee of \$15.00 in addition to the normal ski school fee, Little Switzerland offers an optional Competition Agreement that does not require me to sign a release of liability. In signing this Release of Liability, I acknowledge I am aware of this option offered by Little Switzerland and hereby waive my right to purchase the same.

In accordance with Wisconsin law, nothing in this Release of Liability should be construed as releasing, discharging or waiving any claims I may have for reckless or intentional acts on the part of Schmitz Brothers, LLC, or its owners, officers, shareholders, agents or employees.

I HAVE CAREFULLY READ THIS COMPETITION RELEASE OF LIABILITY AND UNDERSTAND ITS CONTENTS. I AM AWARE THAT BY SIGNING THIS COMPETITION RELEASE OF LIABILITY, I AND MY MINOR CHILD/WARD AM WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE SCHMITZ BROTHERS, LLC, ITS OWNERS, OFFICERS, SHAREHOLDERS, AGENTS OR EMPLOYEES FOR CERTAIN CLAIMS.
